While working at MU's Office of Social and Economic Data Analysis, he oversaw the Missouri KIDS Count project, worked with Missouri's Department of Elementary and Secondary Education (DESE) on a number of survey projects, and became Missouri's statewide evaluator for federally funded afterschool programs. In his role as IPP's Associate Director, he has continued to work with DESE as PI on projects that helped to support and evaluate its federally awarded Preschool Development Grants. His professional interests include measurement and evaluation, particularly in the early childhood and youth development arenas.
